





Latar Belakang : *Stress parenting* adalah kondisi psikologis yang dialami oleh orang tua dalam merawat dan membesarkan anaknya. Seiring dengan bertambahnya usia anak maka tantangan yang akan dihadapi juga semakin besar. Tingkat stres yang dirasakan juga relative lebih tinggi. Orang tua akan mengalami dampak psikologis ketika mengasuh, seperti merasa stres yang berkepanjangan. **Tujuan :** Untuk menggali dan memahami dinamika stres yang dialami orang tua dalam pengasuhan anak dengan ASD, termasuk penyebab, upaya pengelolaan stres, serta faktor pendukung dan penghambat yang memengaruhi stres tersebut.

Metode Penelitian : Desain penelitian menggunakan desain penelitian kualitatif eksploratif Design. Menggunakan Teknik sampling *snowball sampling* dengan 5 responden orang tua yang memiliki anak ASD di Kabupaten Malang. Data dianalisis menggunakan analisis tematik.

Hasil : Hasil analisis tematik mengidentifikasi 3 faktor pendukung utama: (1) dukungan lingkungan sosial, (2) kondisi ekonomi yang stabil, (3) Penerimaan orang tua kepada anak autisme. Sebaliknya tantangan utama diidentifikasi:(1) Keterbatasan sumber daya pengasuhan, (2) kondisi ekonomi yang kurang, (3) lingkungan sosial yang kurang mendukung.

Kesimpulan : *Stress parenting* pada orang tua yang mengasuh anak autis disebabkan oleh reaksi emosional, tantangan perkembangan anak, kurang pengetahuan tentang autisme, dan perilaku menantang. Untuk mengatasi stres, orang tua mengandalkan dukungan sosial, spiritualitas, dan terapi. Sementara masalah ekonomi dan komentar negatif lingkungan meningkatkan tantangan. Orang tua memperoleh hikmah seperti kesabaran dan rasa syukur. Studi ini menekankan pentingnya diagnosis dini, edukasi tentang autisme, serta dukungan sosial dan ekonomi untuk meningkatkan kualitas hidup keluarga.

ABSTRACT

DYNAMICS OF PARENTING STRESS: MANAGING CHALLENGES AND SUPPORT IN PARENTING CHILDREN WITH AUTISM SPECTRUM DISORDER (ASD)

Background : Stress parenting is a psychological condition experienced by parents in caring for and raising their children. As the child gets older, the challenges they will face will also increase. The level of stress felt is also relatively higher. Parents will experience psychological impacts when parenting, such as feeling prolonged stress.

Purpose : To explore and understand the dynamics of stress experienced by parents in raising children with ASD, including causes, stress management efforts, and supporting and inhibiting factors that influence this stress .

Research Methods : The research design uses exploratory qualitative research design. Using snowball sampling technique with 20 respondents who are parents who have children with ASD in Malang Regency. Data were analyzed using thematic analysis.

Result : The results of the thematic analysis identified 3 main supporting factors: (1) social environment support, (2) stable economic conditions, (3) parental acceptance of children with autism. Instead, the main challenges were identified: (1) Limited parenting resources, (2) poor economic conditions, (3) a less supportive social environment.

Conclusion : Parenting stress in parents who raise autistic children is caused by late diagnosis, emotional reactions, child development challenges, lack of knowledge about autism, and challenging behavior. To cope with stress, parents rely on social support, spirituality, and therapy. While economic problems and negative comments from the environment increase the challenges. Parents gain wisdom such as patience and gratitude. This study emphasizes the importance of early diagnosis, education about autism, and social and economic support to improve the quality of family life.
