




## ABSTRAK



Penelitian ini bertujuan untuk menganalisis efektivitas peran ECPAT (End Child Prostitution, Child Pornography and Trafficking of Children for Sexual Purposes) dalam menangani kurangnya bantuan bagi korban eksploitasi seksual anak laki-laki melalui program Inisiatif Anak Laki-laki Global di Maroko, Bolivia, Korea Selatan, dan Thailand dengan menggunakan Teori Efektivitas INGO. Penelitian ini menggunakan desain penelitian deskriptif kualitatif, mengumpulkan data melalui studi dokumen dari buku, jurnal, laporan, dan sumber lainnya. Temuan dari penelitian ini menunjukkan bahwa di Maroko, kolaborasi dengan AMANE dan Bayti berhasil meningkatkan kesadaran masyarakat tentang eksploitasi seksual anak laki-laki dan menyediakan layanan intervensi yang lebih baik. Di Bolivia, kerjasama dengan Fundación Munasim Kullakita (FMK) menghasilkan peningkatan layanan perlindungan anak dan pengurangan stigma. Di Korea Selatan, ECPAT dan Tacteen Naeil berhasil meningkatkan kapasitas konselor dan penerimaan layanan bagi penyintas anak laki-laki. Di Thailand, kerjasama dengan Urban Light memberikan bantuan langsung kepada anak-anak yang berisiko dan penyintas eksploitasi seksual. Meskipun begitu, cakupan intervensi masih terbatas pada wilayah perkotaan dan masih diperlukan peningkatan transparansi dan akuntabilitas dalam mendokumentasikan hasil dan laporan keuangan.

## ABSTRACT

This study aims to analyze the effectiveness of ECPAT's role (End Child Prostitution, Child Pornography, and Trafficking of Children for Sexual Purposes) in addressing the lack of assistance for boys' sexual exploitation victims through the Global Boys' Initiative program in Morocco, Bolivia, South Korea, and Thailand using the INGO Effectiveness Theory. This research employs a qualitative descriptive research design, collecting data through document studies from books, journals, reports, and other sources. Findings from this study indicate that in Morocco, collaboration with AMANE and Bayti successfully increased public awareness of male child sexual exploitation and provided better intervention services. In Bolivia, cooperation with Fundación Munasim Kullakita (FMK) resulted in improved child protection services and reduced stigma. In South Korea, ECPAT and Tacteen Naeil successfully enhanced counselor capacity and service acceptance for male survivors. In Thailand, collaboration with Urban Light provided direct assistance to at-risk children and sexual exploitation survivors. However, intervention coverage remains limited to urban areas, and there is still a need for increased transparency and accountability in documenting results and financial reports.


